

TERMS AND CONDITIONS OF USE

Article 1 – About the Site

tripadescole.com (hereinafter "the Site") is a personal, non-commercial, ad-free website dedicated to sharing content related to the Professor Layton video game franchise (articles, analyses, media, etc.).

Article 2 – Purpose and Acceptance of the Terms

These Terms and Conditions of Use ("Terms") define the conditions under which any person ("User") may access and use the Site, whether as a visitor or registered member.

By accessing the Site, Users unconditionally accept these Terms. Users who do not agree with these Terms must refrain from using the Site.

The Site owner reserves the right to amend these Terms at any time. The applicable version is the one in force at the time of access.

Article 3 – Access to the Site

3.1 Free access

Most content on the Site is freely accessible to anyone with an internet connection, without registration. No account is required to browse the Site.

3.2 Members-only content

Certain content is reserved for Users with an active account. Access to such content requires prior registration as described in Article 4.

Article 4 – Account Creation and Management

4.1 Registration

Users may create a free account by providing the following information:

- A username (display name of their choice)
- A country of residence
- A valid email address

Users agree to provide accurate information and to keep it up to date. Providing false information may result in account deletion.

4.2 Login credentials

Users are solely responsible for keeping their login credentials confidential. They agree not to share their credentials with third parties and to notify the Site owner immediately in the event of any unauthorised use of their account.

4.3 Account deletion

Users may request the deletion of their account at any time by contacting the Site owner at the email address provided in Article 1. The Site owner also reserves the right to suspend or delete any account in the event of a breach of these Terms.

Article 5 – Intellectual Property

5.1 Site content

Original content published on the Site (texts, analyses, layout, organisation) is the property of its author and is protected by copyright. Any reproduction or distribution without prior written authorisation is strictly prohibited.

5.2 Professor Layton franchise

Professor Layton is a franchise owned by Level-5 Inc. Elements derived from this franchise (names, visuals, universe) present on the Site are used in a purely fan-made and non-commercial context, with no affiliation or partnership with Level-5.

The Site makes no claim of ownership over these elements. Should the rights holder request their removal, the Site owner undertakes to comply as soon as possible.

Article 6 – Personal Data Protection (GDPR)

6.1 Data controller

Personal data collected through the Site is processed by the Site owner, reachable at: Tripadescole@gmail.com, in accordance with the General Data Protection Regulation (GDPR – EU 2016/679) and applicable French data protection law.

6.2 Data collected

When creating an account, the following data is collected:

- Username
- Country of residence
- Email address
- Password (stored in encrypted form, never accessible in plain text)

No banking or payment data is collected. The Site displays no advertising.

6.3 Purposes of processing

Data is collected solely for the following purposes:

- Creating and managing user accounts
- Providing access to members-only content
- Ensuring the security and integrity of the Site

6.4 Legal basis

Processing is based on the performance of a contract (these Terms), to which the User consents upon registration.

6.5 Retention period

Data is retained for the duration of the account's activity. Upon account deletion, data is erased within 30 days, unless otherwise required by law.

6.6 Data hosting

As the Site is hosted on the Wix platform, data may be stored on servers located outside the European Union. Wix is committed to complying with the appropriate safeguards required under the GDPR. For more information: <https://support.wix.com/en/article/wix-privacy-policy>

6.7 User rights
